DELIVERY & RETURN

Artist is responsible for transit of accepted artwork to and from the Baker Arts Center. Shipped artwork must be by UPS or Fed-Ex only and is ineligible without a PREPAID return label. No C.O.D. shipments. Accepted work(s) must be shipped in reusable cartons, (no loose packing peanuts). Use screws only in wooden crates. Artwork must arrive at the Center no later than 5:00 p.m. CDT, March 28, 2012. Any artwork remaining at the Center after May 31st will be considered a donation and a receipt will be sent.

The Baker Arts Center will not assume liability for loss or damage of artwork during transit or while at the Center. Artists may secure their own insurance. The Center provides electronic security protection against fire and theft while artwork is here.

LIABILITY

The juror is Carol Fullerton-Samsel, owner of Only Originals Gallery of Fine Art, an online exhibition venue. Carol received a Bachelor of Fine Arts from Wesleyan College, Macon, GA and attended graduate school at the University of Florida. She has written numerous publications, news articles, and exhibited extensively across the United States.

JUROR

This Exhibition is open to artists 18 years and older who are residents of the USA or Puerto Rico. Original 2 & 3-dimensional works including drawing, painting, photography, printmaking, ceramics, wood, paper, enamels, glass, metalsmithing, collage, and mixed media, completed since January 2010 and not previously shown in this exhibit are acceptable. Textiles, crafts, video, kit work, and reproductions are not accepted. Entries must be available for exhibition at the Center April 7—May 26, 2012.

ELIGIBILITY

Baker Arts Center retains a 30% commission on all sales.

FEES

RETURN NOTIFICATION

Artists must include a #10 SASE for notification. Baker Arts Center will retain accepted images for promotional purposes.

Art work must not measure over 60" in any direction. Accepted entries must be ready to hang or display. 2-dimensional work must include a wire secured with screw eyes for hanging. No exceptions.

SPECIFICATIONS

JUDGING

Only juror accepted works will be exhibited. NO SUBSTITUTIONS. Final judging will be on site. Juror may reject entries deemed inappropriate for exhibition upon viewing actual artwork. Baker Arts Center may select another juror of similar rank if juror is unable to complete responsibilities. Artists will be notified in this event. All slides/images must arrive at the Center by 5:00 pm CT on February 3, 2012.

EMAIL DIGITAL IMAGE FILES

No CD's. Digital images must be in JPEG format with a maximum of 1024 pixels in the longest dimension. Files must not exceed 1 Megabyte. JPEG images must be sent via email as an attachment and be identified by artist's first name initial, last name and entry letter to correspond to entry form information, ie. JSmith-a.jpg. Artists who send in email entries may also send a SASE for notification purposes via postal mail, otherwise notification will be via email.
